Important Notes:

- The candidate's names given in the **Annexure A** are calling for Document Verification on the basis of their willingness invited in a prescribed format for willingness under the vide notification no. 11/ADMIN/AIIMS-BPL/2019/510 Dated 01/02/2019.
- The candidature of the shortlisted candidates for Document Verification is purely provisional subject to verification and fulfilment of the eligibility criteria with regard to age, category, essential qualification and experience etc. as per the advertisement and Rules & regulation of the Institute. In case any of the selected candidates who if found not fulfilling any of the eligibility criteria, at any stage then his/ her candidature /selection will be treated as cancelled without giving any reason. - AIIMS, Bhopal will not pay any travelling and other expenses to you for above said document verification.
- Document verification may also continue for one more day other than the scheduled date. Candidates are advised to come with preparation to stay for next day accordingly.
- **If the candidate(s) whose name does not mention in the list of the Notification and they have already sent a e-mail for their willingness as per Notification, such candidates are advised to report the discrepancy along with all supporting documents/proof to Administrative Officer, All India institute of Medical Sciences, Administrative Block, 1st Floor Medical College Building, Saket Nagar, Bhopal one day before the scheduled document verification as mentioned in this Notification for resolve the issue as per rule.**
