2. The Hospital Management Board (HMB) shall be an advisory body for the management of AIIMS Hospital with following functions primarily:

- a) It will look after all Hospital related affairs viz. starting new department, issue related to patient care, budgeting of hospital.

- b) It will also oversee construction activities in the hospital premise, the use of vehicles, equipment, water supply, cleaning and waste management.
- c) It will ensure the implementation of various programmes /policies/schemes etc. as per directions issued by Government of India from time to time with regard to patient care and national Health Scheme like INDRADHANUS, AYUSHMAN BHARAT etc.
- d) It will keep an eye on purchase of medicines, furniture and equipments, ensuring of transparency in the functioning of the hospital.
- e) It will ensure steady development of the Hospital and will take up responsibilities for the better functioning and improvement of the Hospital.

3. Hospital Management Board shall meet at least once in every three months, and a specific time and day will be fixed for that.

4. No decisions regarding policies/procurement or any other issues related to hospital can be finalized, if the quorum not present at the meeting i.e. unless 2/3<sup>rd</sup> of the total members (including Chairman) are present.
